LEADERSHIP NORTHWEST

In February, the Leadership class met for their session on Human Resources. The mission of the session was for them to learn more about the human resource side of leadership. This is important for them as they become leaders because being an effective leader starts with understanding your employees and colleagues and their individual needs.

Their day started with some time to work with on their group projects and each group presented their progress to the advisors. They are all well on their way!

Beth Dupont, Human Resources & EEO Officer at O&G Industries, Inc. presented a workshop on Hiring/Firing, Communication and the Generation Gap. Beth talked about developing staff, putting out fires, being candid and kind with employees, focusing on employees' strengths and accomplishments, not getting caught up with things that aren't work related, interpersonal skills, addressing the bad egg, fairness to the group- don't let one person ruin it for everyone, courageous conversations with your staff, interviewing, and culture. One of her favorite pieces of wisdom to share is that "culture eats strategy". She gave examples of how culture can derail all productivity. The class had a chance to ask questions and the discussion was very interactive.

After lunch, the class went to Northwestern CT Community College for the afternoon session. Mike Emanuel, Professor/Program Coordinator of the Criminal Justice program, did a great presentation on Violence in the Workplace. In addition to talking about what to do in case of an active shooter (whether in your workplace or some other public place where you might be), he gave basic safety tips to make sure you are always aware of your surrounding and exits. To demonstrate this, Mike asked the group how they would get out of the room if the door was blocked. He had everyone get up and go to the windows, try to open them and determine if they could escape via the window. Mike also talked about risk factors for violent behavior in the workplace. He talked about the importance of having a safety plan and what to do if you need to escape or fight off a violent person. There was also questions and answers, both work and personal related, and the group now feels more knowledgeable and empowered to act if they are ever confronted with a workplace (or personal) violent situation.

SEXUAL HARASSMENT PREVENTION TRAINING

Connecticut's Time's Up Act Requires: employers to provide all existing employees with two hours of training by October 1, 2020, employers to provide two hours of training and education to new employees hired on or after October 1, 2019 within six months of their start date, employers to provide two hours of training and education to all existing supervisory employees by October 1, 2020 or within six months to new supervisory employees, employers to provide periodic training not less than every ten years.

The Chamber is now hosting Sexual Harassment Prevention Trainings to fulfill these requirements. The next available date is **March 10**th from 8-10 am. THERE ARE ONLY 3 SPOTS LEFT, so reserve your space today.

This Sexual Harassment In the Workplace seminar will cover all aspects of the new statutory requirements for employers, including, information about what has changed, what new obligations exist for employers and where employers can find additional resources to ensure compliance. The presentation and discussion will also focus on understanding the spectrum of workplace conduct that constitutes sexual harassment, best practices in appropriately addressing sexual harassment and, in understanding the legal implications employers should be aware of when dealing with harassment issues in the workplace.

LEADERSHIP NORTHWEST After Mike, Stacey Williams, Associate Business Professor, talked about Emotional Intelligence and she explained the importance in the workplace. Specifically, it costs businesses money not to be emotionally intelligent because people will leave the organization (and it costs roughly 1/3 their annual salary to replace them) and if people don't leave, they're absenteeism will likely increase and absenteeism in the US costs roughly \$78 billion annually. Stacey talked about how to increase your emotional intelligence (get to know yourself, learn your emotional triggers, empathize with others, own your emotions, and go with your gut). She then talked about the four domains of emotional intelligence: self-awareness, self-management, social awareness, and relationship management. She handed out an emotional intelligence self-assessment for the participants to complete. She asked for volunteers to talk about which area was their strength, then she talked about the pluses and minuses of each of those strengths and tying it directly to how that affects them as leaders/supervisors.

MANUFACTURERS' COALITION The March Manufacturers' Coalition meeting took place on the 6th at Housatonic Valley Regional High School. The Coalition met with the Robotics Team for a demonstration on what they've been working on this year. The Team left the following day for a big competition.

The Robotics team was founded in 2001 by Dave Lindsay and Tom Schindler, teachers at HVRHS, after learning of the program at a teacher conference. They enlisted the aid of Andy Brockway, an engineer working at Becton Dickinson. Their team placed FIRST at the 2001 kick-off. From then on, the team has continued to see success at competitions, grow as an after-school program, and be an invaluable resource for its students. The team also supports Lego League and currently mentors several teams in the area.

Following the meeting, some of the manufacturers stayed to talk to the students about their careers and how they can get into the industry after graduation.
