As you know, the SBA is getting ready to open applications for the Restaurant Revitalization Fund (RRF). As such the Connecticut District Office will be holding multiple sessions to give an overview of who is eligible, use of funds, how to apply and the priority application process. The American Rescue Plan appropriated \$28.6 billion to RRF and authorized SBA to award funds, not loans. It is important to get the most accurate information out to our Connecticut businesses and entities.

Eligible businesses include food stands, food trucks, food carts, caterers, bars, lounges, taverns and restaurants. Also eligible are snack and nonalcoholic beverage bars (e.g., coffee shops, ice cream shops),

bakeries, brewpubs, tasting rooms, taprooms, breweries and/or microbreweries, wineries and distilleries to name a few more.

#### **COVID-19 Restriction Update**

Governor Lamont just announced plans to further ease and then eliminate most of the state's COVID-19 restrictions contingent upon Connecticut maintaining sufficiently low rates of infections and increased vaccination rates. Effective Saturday, May 1, 2021

• The curfew for restaurants, entertainment venues, recreation venues, and theaters will be moved back one hour to 12:00 am midnight.

• Bars that do not serve food can open for service – OUTDOOR ONLY. Food is still required when serving alcohol indoors.

• The 8-person per table limit will be lifted – OUTDOOR ONLY. The limit remains in effect for indoor dining.

#### Effective Wednesday, May 19, 2021

• All remaining business restrictions will end.

• The Connecticut Department of Public Health (DPH) will issue recommendations for indoor and large outdoor events (e.g., concerts).

• Indoor masks will continue.

If you have any questions about these changes, information is available on the state's <u>Sector Rules</u> page. We encourage all Connecticut residents over the age of 16 who have not been vaccinated to <u>schedule their</u> <u>vaccination</u> today. Getting vaccinated protects you and the people around you. It also remains the most important thing we can do to ensure a smooth reopening.

#### BUSINESS TO BUSINESSVACCINATION OUTREACH PROGRAM NW REGION – Hartford HealthCare and the NW Chamber of Commerce April 2021

PROBLEM STATEMENT: A full economic recovery requires an immune workforce and consumer-base. To this end, and to continue increasing vaccine uptake, distribution and dispensing efforts must become more mobile and flexible, outreach and education efforts must be more tailored, and partnerships between and among employers and business organizations with health care providers must be taken to the next level.

OPPORTUNITY STATEMENT: By combining forces, Hartford HealthCare and the NW Chamber of Commerce have organized a membership vaccine outreach program. All Chamber members will be offered an opportunity to request vaccinations for their employees, and depending on demand can arrange on-site vaccinations, participate in nearby mobile vaccination sites, or arrange clinic access with reserved appointment times for their workforce.

THE PROGRAM: Charlotte Hungerford Hospital, a partner of Harford HealthCare, has set up a mobile team of clinicians and have eliminated registration and appointment hassles many have encountered to date. As requests from Chamber Members are received, we will schedule our mobile team with an emphasis on arranging as many on-site vaccinations as possible. Secondarily, in some cases a near-by central mobile vaccine distribution site will be established to which several businesses can participate will be arranged such as in an industrial park. Finally, the option of priority appointments at fixed clinics sites in Torrington can be arranged.

WHAT'S NEXT: On Friday 4/30, The NW Chamber of Commerce will send a communication to all of its members inviting them to consider this opportunity and if desired directing them to call Pam Tino at the CHH Business Vaccine Registration Line at 860-496-6725. It is our intention to begin this effort as soon as the following week and sustain it for as long as there is demand.

## SHARON HOSPITAL, FOUNDATION FOR COMMUNITY HEALTH PARTNER FOR SUSTAINABLE HEALTHCARE REPORT

SHARON, Conn. — April 22, 2021 — To envision a stable Sharon Hospital of the future, the leadership team and board of directors have partnered with the Foundation for Community Health to study the development of a sustainable healthcare model to support medical needs in northwest Connecticut and northeast New York for years to come.

Intending to identify realistic and implementable best practices for the delivery of care in rural communities, the report will examine the demand for services and programs, in addition to fiscal and operational performance evaluations. With consideration for historic, current and anticipated community need, the review will also include insights from recent interviews and previous community health needs assessments, town halls, public hearings and the many community meetings held over the past 18 months.

The study is led by Stroudwater Associates, a private healthcare consulting firm that helps strengthen the vital role of hospitals and clinics in rural America across strategic, financial, clinical and operational areas.

"We share an obligation to improve the region's quality of life with comprehensive programs that support our rural communities," said Dr. Mark Hirko, president of the hospital. "This collaboration is an innovative step to ensure Sharon Hospital delivers sustainable care for the foreseeable future."

Survey data, to be shared with the community upon completion, will offer key guidance as Sharon Hospital looks to adapt an operational and financially viable model of care aligned with best practices for rural hospitals.

"It is our hope that this study results in the development of an actionable plan for Sharon Hospital that will ensure its resiliency, enhance its responsiveness to the community and allow it to continue to play its historically critical role as an anchor for all healthcare services," said Nancy Heaton, CEO for the Foundation for Community Health.

As the hospital and community work to evolve beyond the COVID-19 pandemic and other economic challenges, the study will bridge knowledge about barriers, trends and determinants to healthcare access in rural areas, such as proximity, affordability, utilization, resources, socioeconomic status and population demographics.

Funding for the analysis was awarded to Sharon Hospital by the Foundation for Community Health, also located in Sharon. The private, nonprofit foundation is dedicated to improving the health and well-being of residents in the greater

Harlem Valley in New York and the northern Litchfield Hills of Connecticut, with an emphasis on serving those most vulnerable.

#### CHH RECEIVES \$120K GRANT FROM THE ROBERT ROSENHEIM FOUNDATION FOR ITS YOUTH AND FAMILY CENTER

**TORRINGTON, Conn.** The Charlotte Hungerford Hospital Center For Youth and Families in downtown Torrington has recently received a generous \$120,000 grant from the Robert Rosenheim Foundation.

The Center for Youth and Families will be using the funds to equip its conference room at the Center with state of the art technology to enhance the video and telephone mental health services they offer to the community. These new resources will help the staff overcome the barriers to access and delivery of care and counseling as well as enhance collaborations with other healthcare and child advocacy professionals throughout the region and state.



"Improving access is so important especially now with increased mental health needs due to the pandemic and the long term access issues that exist for kids in the far Northwest Corner." Said Joan Neveski, LCSW, Director of the Center For Center Youth and Families. "This will also help enhance sessions with patients where transportation is a physical or monetary barrier including those families in rural Northwest Connecticut who experience long round trips to Torrington with little mass transit opportunities. It will also provide an opportunity to connect to children and their caregivers during inclement weather situations where travel is not advised." Joan added.

Remote family sessions also benefit children by giving people the opportunity to connect from their home if they cannot attend sessions otherwise due to various reasons. Using telehealth also improves coordination and communication

with Center staff, educators, healthcare providers, psychiatrists, and pediatricians. The new technology will also

assist Center staff provide more accessible group therapy and trainings where the sound and video capability will be top of the line.

#### CHH Diabetes Education Program Receives ADA recognition

**TORRINGTON, Conn...**The American Diabetes Association (ADA) has recently awarded CHH Diabetes and Endocrinology of Torrington a prestigious recognition certificate for their diabetes self-management education and support education program. The designation means ADA believes the service offers highquality education that is an essential component of effective diabetes treatment.

To qualify, the Torrington program had to meet the National Standards for Diabetes Self-Management Education and Support that were developed and tested under the auspices of the National Diabetes Advisory Board most recently revised in 2017. Services that achieve recognition status have a staff of knowledgeable health professionals who can provide participants with comprehensive information about diabetes management. Education Recognition status is verified by an official certificate from ADA and awarded for four years.

"I thank all of my colleagues for making this achievement possible. Receiving this recognition and complying with ADA national standards that measure the quality of services we offer provides real peace of mind for our patients and community." said CHH Certified Diabetes Educator Lois Pelletier, RN CDCES.

According to the Centers for Disease Control and Prevention (CDC) 30.3 million people or 9.4% of the population in the United States who have Diabetes. While an estimated 23.1 million have been diagnosed, unfortunately, 7.2 million people are not aware that they have this disease. Each day more than 3,900 people are diagnosed with diabetes. Many will first learn that they have diabetes when they are treated for one of its life-threatening complications – heart disease, stroke, kidney disease, blindness, nerve disease, and amputation.

Dr. Egils Bogdanovics, Dr. Deepti <u>Rawal</u>, David Ohotnicky APRN, Lois Pelletier RNCDCES and Bonnie Blethen RD offer a comprehensive and multi-disciplinary approach to diabetes treatment and disease management. The staff are certified diabetes specialists that are specifically trained to help people with diabetes avoid complications and maintain better health.

The practice at 780 Litchfield Street, Torrington, operates the ADA recognized program to help people with diabetes and offers insulin pump training, weight loss programs, carbohydrate counting classes, and continuous glucose monitoring. The team of board certified diabetes physician specialists, certified diabetes educators, and registered dietitian, are specifically trained to help people with diabetes avoid complications and maintain better health throughout their lifetime. Their goals are to provide a comprehensive and multi-disciplinary approach to diabetes treatment and disease management.

#### CHH & TORRINGTON LIONS CLUB LOW VISION CENTER NOW AT SKYTOP PLAZA OFFERS HELP TO PATIENTS WITH SIGHT LIMITATIONS

TORRINGTON, CT... Are you or someone you know experiencing the challenges of low vision? Charlotte Hungerford Hospital and the Lions Low Vision Centers of Hartford and Litchfield counties partner together to help by provide free medical and financial support to those affected by assessing their sight limitations.

The Lions Low Vision Center is now located at the Hartford HealthCare Rehabilitation Network office at the Sky Top Plaza, 1012 East Main Street in Torrington. The service is provided by appointment by Registered Occupational Therapist Michelle Whitford who has extensive training in low vision diagnoses and treatment.

"Low vision affects over two thirds of adults over 65 years of age. It's our goal to ensure that older adults with low vision are able to maintain their independence and experience quality of life." Said Michelle Whitford.

Macular degeneration, glaucoma, or history of stroke or Diabetes, are the most common medical conditions causing low vision. Simple tasks may become more difficult and frustration often occurs with low vision. Although low vision can't be corrected, there are many ways to make daily tasks easier.

Low vision is a condition that can't be corrected by medical or surgical intervention or by eyeglasses. It limits an individual's ability to complete many daily activities, which may include any of the following examples: reading and signing forms, reading the numbers on a clock, or difficulties locating steps, curbs or items within one's home.

Our hospital is pleased to partner with the Lions as we are inspired by them. The Center is really made possible by their resources and encouragement." Said Brian Mattiello, VP of Strategy and Community Development at Hartford HealthCare Northwest Region.

Patients begin with an assessment to determine their degree of vision loss and then an individualized plan is created with specific goals focused on providing assistance and improving their quality of life. Strategies are then developed to help people perform daily tasks, at times using tactile and talking products. Individuals are educated on availability of assistive technologies and learn to use their remaining vision effectively and live more safely and independently. The service is covered by most insurances which are billed for services provided. The Lions Low Vision Centers supplies any devices a patient may need free of charge and may also assist in financial hardship situations. #### YOU WILL NEVER WALK ALONE

The global pandemic seems as if it has been with us forever. The past year been a challenging and difficult experience for us all. At times it seemed as if normalcy would never again be possible, that hope had been completely extinguished. But now, as spring begins again, with more than half of all Connecticut residents on their way to being fully vaccinated, we are close to breathing our first collective sigh of relief. Rules and restrictions are relaxing and there is hope in the air. While maintaining and promoting safety, it is equally important that we give ourselves permission to celebrate the great progress that is being made, recognize our part in that progress, and look to the future with hope and assurance.

#### Suicide Rates Drop 17% in CT

The Journal of the American Medical Association (JAMA) recently published a <u>report</u> on the leading causes of death in 2020 in the US. The report showed a 6% decrease in suicide deaths, the only cause of death that decreased. In Connecticut, we saw a 17% decrease, three times greater than the national average. Surprising even the experts, the 18-24 age group saw the greatest decrease in suicide death similarly among all races.

The drop may be due to suicide prevention programs, such as <u>Zero Suicide</u> here in CT, and mental health promotion. It may also be explained through the support of a collective



human experience. Suicidologists have observed this same drop in suicide deaths during times of trauma and catastrophe (war, famine, disease etc). There seems to be a sense of community after a disaster, helping people to feel part of something, looking externally, and helping their pain to become more tolerable.

#### **Give Yourself Grace**

As we slowly return to normal, we need to be aware of our own emotions and those of our loved ones. For both adults and children who experience anxiety or have become used to being at home, returning to work, school, or social situations may bring uncomfortable feelings. For every parent, the wellbeing of their children is what matters most. We try to be aware of arising issues and try to bring comfort, but we cannot always know everything that our children are going through. We make mistakes, we misjudge, indeed sometimes we fail. We are only human after all.

Keep in mind that when we are hard on ourselves and focus only on our failures or deficiencies, we are worse off. If we speak to ourselves kindly and allow ourselves grace and forgiveness, we will be better parents, partners, friends, employees, and neighbors. Remember you do not have to walk alone. #### NCCC SELECTED TO ATTEND RESEARCH CENTER'S INSTITUTE

Northwestern Connecticut Community College has been selected to attend the Community College Research Center's Summer 2021 Institute.

The Community College Research Center at Columbia University is an independent research center that studies two-year college institutions to strengthen opportunities and improve outcomes for their students, particularly those from underserved populations, an announcement from NCCC said.

The Institute is designed to help rural and rural-serving colleges overcome the challenges they face in implementing

With the support of CCRC researchers, NCCC will develop data-driven plans for implementing reforms that will help the community college to recruit and



retain students, improve student success rates and close equity gaps. NCCC will receive additional support from CCRC researchers through the end of 2021.

NCCC will attend the institute virtually, during the month of July and will begin implementing the reforms in the fall.
